

March 2024 Quarterly Activities Report

Highlights

- Design transfer activities completed, with reliable and reproducible data supporting progression to prototype manufacture

MELBOURNE, AUSTRALIA, 29 April, 2024: Ovarian cancer diagnostics company, Cleo Diagnostics Limited (ASX:COV) (CLEO, or the Company) is pleased to provide the market with an update on activities in the March 2024 quarter as it develops its simple and accurate blood test for the early detection of ovarian cancer.

2nd PEER REVIEWED PUBLICATION

The article, entitled 'Reclassification of patients with ambiguous CA125 for optimised pre-surgical triage' was published in the peer reviewed medical journal, Diagnostics.

The article concluded:

- a) CLEO's test correctly identified most cancer cases missed by CA125, including a majority of patients with early stage cancers;
- b) The test provided superior identification of benign disease to eliminate the majority of "false positive" results obtained using CA125; and
- c) The test efficiently discriminated malignant from benign samples.

Background

Further data for CLEO's ovarian cancer triage test has been published in the peer-reviewed international journal 'Diagnostics'.

Whilst these clinical studies are complex documents to interpret for the lay-reader, they form an integral part of Cleo's commercialisation strategy. They are crucial for providing documentary evidence of Cleo's test performance and will be used:

- To support Cleo's case to be included in national and international medical guidelines;
- To support Cleo's applications for private insurance coverage in the USA; and
- To inform clinicians of Cleo's test performance to drive uptake.

The latest study assessed the use of CLEO's triage test to rescue those cases where CA125 provided an incorrect indication. Accurately identifying cancer patients early is critical to provide immediate referral to a gynaecological oncology specialist for surgery; whilst allowing better management of patients with non-malignant disease.

The study compared the potential clinical benefit to patients if CLEO's Test was used for initial diagnostic work-up instead of CA125, the current gold standard ovarian cancer biomarker.

CLEO's triage test accurately re-assigned the majority of "missed" cancers that were incorrectly identified as low risk using CA125, and was effective in both pre- and post-menopausal patients.

False negative detections (i.e. a "missed" cancer case) were reduced by ~71% for post-menopausal patients and ~54% for pre-menopausal patients, many of whom had early-stage disease. This is particularly important in the pre-surgical setting, where rapid identification and triage to a gynaecological oncology surgeon is critical to achieve greatest benefit for patients.

Similarly, false positive detections (i.e. where CA125 incorrectly classified benign disease as "high-risk") were reduced by ~57% and ~75% for post- and pre-menopausal patients respectively. This is essential to reduce unnecessary surgical interventions, which has significant relevance for pre-menopausal women where cancer diagnoses are typically rare and fertility preservation strategies are highly important.

Improvement Over Existing Technology

The current "gold-standard" tumour biomarker Cancer Antigen 125 (**CA125**) has poor accuracy, particularly for the detection of early-stage disease and discrimination between benign versus malignant status.

Around 20% of ovarian cancers do not express CA125, and it is often in the "normal" range in patients with early-stage disease. False negative CA125 results (where cancers are "missed") are common, and complicate the referral of cancer patients to a gynaecologic oncology specialist for primary surgery.

Conversely the abnormal elevation of CA125 in non-malignant conditions (e.g. endometriosis, fibroids, pelvic inflammatory disease and others) results in high false positive detection (where benign cases are



incorrectly suspected to be cancer). Unsurprisingly, post-surgical diagnoses of benign disease outnumber malignancy by ~9:1.

CLEO's latest data highlights the use of its triage test to rescue those cases where CA125 proves inaccurate, and demonstrates significant potential to improve the initial clinical management for patients with malignancy – particularly at an early stage.

The importance of the latest release of data for Cleo, is that starts to layout for the medical guideline bodies and the private payors how well Cleo's technology performs compared to the existing paradigm.

U.S. Market Access Program

The U.S. represents CLEO's largest market opportunity for its ovarian cancer blood test and is the focus for initial regulatory approval through the Food and Drug Administration (FDA). In order to successfully execute on its U.S. market entry plan, CLEO will partner with New York-based strategic healthcare consultancy, HcFocus, appointing the company now to assist it with commencing commercial activities.

HcFocus specialises in helping med-tech companies access the U.S. healthcare market by leveraging their deep healthcare industry experience and networks to deliver market access results.

CLEO will leverage HcFocus' expertise to navigate the complexities of U.S. health systems and regulatory environment, with the companies to focus on a roadmap to achieve:

- FDA approval for CLEO's ovarian cancer blood test;
- Reimbursement, including with private insurers;
- Clinical trials;
- Support KOL appointments; and
- Industry and doctor engagement.

The move to advance the U.S. market access program is well timed following two initial peer-reviewed publications recently released assessing the performance and benchmarking of CLEO's ovarian cancer blood test. These publications detail the performance characteristics of the prototype triage test, which significantly exceeded comparable tests on market and the existing gold-standard biomarker, CA125 – the current guideline mandated test (See ASX Announcements 6 November 2023 and 25 March 2024).

CLEO's publication strategy will underpin market access activities and is designed to publicise the test performance parameters and develop the clinical utility message, essentially building the clinical evidence bank required for doctors and insurers to support and adopt the prescribing of CLEO's ovarian cancer blood test. HcFocus will be able to quickly assess the results from the initial peer-reviewed publications and provide guidance to ensure that Cleo's evidence package will meet the needs of U.S. reimbursement bodies, including the private insurers. Further clinical evidence will be delivered in the coming months as the Company progresses towards the initial FDA 510(k) application for the pre-surgical triage test.

U.S. Ovarian Cancer Clinical Trials

As a part of CLEO's U.S. market access program, the Company will partner with U.S.-based CRO, Lindus Health, appointing it to manage the successful execution of its ovarian cancer U.S. clinical trials. Lindus Health was chosen following a robust process to identify a partner with the proven experience, technology and high standards capable of delivering on CLEO's objectives.

Lindus Health specialises in collaborating with med-tech companies to conduct clinical trials worldwide, leveraging their innovative patient recruitment and trial management technology platform to deliver efficient and timely outcomes.

Comprehensive U.S. patient data is essential for a successful regulatory application through the Food and Drug Administration (FDA). CLEO will leverage Lindus Health's expertise to execute a cost-effective and rapid clinical study that will support its subsequent FDA 510(k) application.

The study will benchmark CLEO's pre-surgical ovarian cancer triage test and provide the core data requirements for the FDA 510(k) application. Up to 500 U.S.-based patients will be recruited, with the trial scheduled over 10 months following ethic approvals and site engagement.

An Australian arm of the trial will also run concurrently and be managed directly by CLEO. This dual-arm strategy mitigates risk to the timelines due to patient recruitment, and will provide additional patient samples for kit verification following manufacture.

The study data will be published in the mainstream medical literature as a part of CLEO's rigorous publication strategy.

Design Transfer

Cleo completed the design transfer in February for the CXCL10 active ratio test into a more rigorous laboratory environment, ensuring the capability to deliver reproducible and reliable results. This advancement enhances the performance of the test, transitioning it from academic methodologies to a compliant and robust laboratory setting. The test will continue to progress through the development pathway, culminating in an FDA 510K application for regulatory approval.

As outlined in the clinical validation study publication (see ASX Announcement 6 November 2023), the CXCL10 active ratio measures changes in a key immune process to give an indication of the presence of a tumour, and is an important component of Cleo's biomarker panel to be incorporated within its commercially available test kits.



Cleo's first product to market will be a pre-surgical triage test, designed to determine the likelihood that a pre-surgical ovarian mass is either benign or malignant prior to referral for surgical intervention. The test will be used in conjunction with clinical and radiological evaluation of a patient by physicians, to improve the referral process and better inform clinical decision making workflows. Ovarian masses (typically benign cysts) are very common and non-life threatening; around 10% of women will have surgery during their lifetime for investigation of an ovarian mass, representing a significant market opportunity for Cleo's first product.

The completion of design transfer forms the basis for Cleo to progress technology transfer to a manufacturer as the next step. The Company is currently finalising a tender process for the selection of an antibody manufacturer and expects it will be in a position to announce a partner shortly, with completion of technology transfer to follow shortly thereafter.

Market And Clinician Engagement

During the quarter, CLEO held a special presentation with a number of doctors in Melbourne to showcase the Company's ground-breaking new diagnostic blood test for ovarian cancer. The event was hosted by CLEO Lead Medical Advisor and Non-Executive Director, Professor Tom Jobling OAM, Chief Scientific Officer and Executive Director, Dr Andrew Stephens, and Chief Executive Officer, Dr Richard Allman.

The presentation covered an overview of the current standard of care, science and potential impacts for CLEO's revolutionary ovarian cancer diagnostic test as well as opportunities to develop insights, network, collaborate during clinical trials, and ultimately calling for support for integration into clinical practice.

CORPORATE

The Company had cash reserves of A\$9.973M as at 31 March 2024.

CleoDX aims to bring to market a simple blood test for the accurate and early diagnosis of ovarian cancer based on the novel patented CXCL10 biomarker, which is produced early and at high levels by ovarian cancers but is largely absent in non-malignant disease. The test aims to distinguish benign from malignant growths in a standard format that will be readily compatible with existing equipment used by diagnostic laboratories worldwide.

The platform is backed by over 10 years of scientific Research & Development at the Hudson Institute of Medical Research, with two clinical studies conducted with over 500 patients. Pursuant to a licence agreement with the Hudson Institute of Medical Research, Cleo has a worldwide exclusive licence to commercialise the intellectual property which underpins its operations and the ovarian cancer tests.

The clinical unmet worldwide need is urgent. An accurate and early detection blood test could shift survivability for ovarian cancer significantly as seen with other cancers. Cleo is advancing the availability of its simple blood test, under a modular execution strategy which is designed to eventually address all ovarian cancer detection markets with specific tests including surgical triage, recurrence, high risk, and early-stage screening.
