TENEMENT GRANTED AT THE TULLSTA PROJECT IN SWEDEN

HIGHLIGHTS

- Exploration permit Tullsta nr 9 with permit number 2021:75 has now been granted at Tullsta Nickel Project
- The grant of Tullsta nr 9 tenement increases the size of the Tullsta Project area by approx. 1,600 Ha (~16km²)
- Ragnar Metals plans to do desktop work and analyse historical data prior to the onset of the Swedish winter
- Drilling has commenced at the Tullsta Project testing EM plates within the Nickel-Copper bearing Granmuren Intrusion




Figure 1: Tullsta Project Tenement Map showing the location of Granmuren Ni-Cu deposit (red star) and the newly granted Tullsta nr 9 tenement (red polygon) south of the existing tenure (blue polygon).

Ragnar Metals Limited ("Ragnar" or "the Company", ASX: RAG) is pleased to announce that the Company's application for the tenement Tullsta nr 9 (Tullsta 9) has now been granted, considerably increasing Ragnar's landholding in the Tullsta area. In June 2021, Ragnar applied for an exploration permit over the Tullsta 9 area. The tenement covers an area of 16km² and is located immediately to the south and south-west of the existing Tullsta Nickel-Copper Project near the town of Sala, within the Bergslagen District of Sweden. The tenements northern boundary is located 1.85km from the Granmuren Deposit (Figure 1). The town of Sätra brunn is located near the centre of the tenement and was excluded from applied area. Ragnar Metals now has five granted tenements at the Tullsta Project, comprising an area of 109.6km² (Figure 1 and Table 1).

The expansion of Tullsta 9 tenement is aligned with Ragnar Metals strategy to expand its prospective coppernickel exploration in the Tullsta Project. The Company has planned to continue progressing targets by data compilation and desktop planning during the winter months in Sweden.

The re-entry and extension drilling of hole 21DDTS002 at the Tullsta Project has commenced. Another 3 diamond core holes have been scheduled, testing the recently generated EM plates¹ which are located within the nickel-copper bearing Granmuren gabbroic intrusion. Ragnar will continue to update the market as drilling progresses.
